If leader or key personnel of this musical group is re-booked into this establishment within 365 days from the completion of this agreement, leader will be liable for payment to STLBlues for 10% commission rate set forth in this agreement. Purchaser and/ or Artist must give STLBlues 30 days (30) written notice of change or cancellation. If cancellation should occur on Purchaser's behalf within thirty (30) days prior to performance, Purchaser is responsible for 100% of Artists fee. In the event of cancellation due to inclement weather, artist will receive 50% of agreed upon fee. It is expressly understood that STLBlues is acting solely as agent for Artist/Purchaser in the negotiation of this contract and is in no way a party to this agreement or responsible of non-performance by any parties hereto of the obligations assumed. STLBlues will not be held responsible in case of sickness, accident death, natural disaster, acts of God or other conditions deemed beyond control. In the occurrence of any of these situations, STLBlues will lend all reasonable assistance to provide quality replacement with the approval of purchaser. Artist must perform clean show. See additional terms and conditions. Indemnification: The Purchaser shall release, indemnify, and hold STLBlues, its trustees, officers, employees, and agents harmless from any and all liability, claims, suits, actions, damages, settlements and expenses, including reasonable attorneys fees, arising out of injuries to persons or damages to property directly and exclusively resulting from STLBlues provision of the Services, STLBlues activities and use of the Purchasers facilities or equipment.
